August Tax Rate Hearing

Assessed Valuation after the Board of Equalization Meeting: \$70,425,004

This is an increase of approximately 6.5% over last year.

Since our assessed valuation grew more than CPI (Inflation) our district falls under the Hancock Amendment which is Missouri Law that protects the tax payers.

Our maximum allowable tax rate levy for 2025-2026 is rolled back from \$4.0700 to \$4.0233

Based on these numbers, we should see an increase in local tax revenue of approximately \$135,000.00

I recommend that the school board set the tax rate levy at \$4.0233 per \$100 of assessed valuation for the 2025-2026 school year.

Nell Holcomb R-IV School District Tax Rate Hearing Notice

A hearing will be held at the School Library on August 27, 2025 at 5:00 PM. District address is 6547 State Highway 177 Cape Girardeau, Missouri. At this time citizens may be heard on the property tax rates proposed to be set by the Nell Holcomb R-IV School District, a political subdivision.

The tax rates are set to produce the revenues from the property tax required by the budget for the fiscal year beginning July 1, 2025. Each tax rate is determined by dividing the amount of revenue needed by the current assessed valuation. The result is multiplied by 100 so the tax rate will be expressed in cents per \$100 valuation.

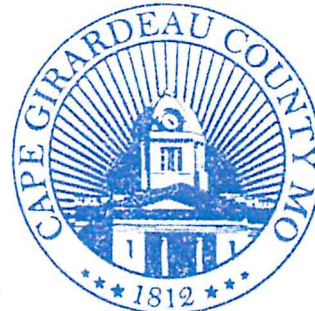
